INFORMATIONAL MEETING
NYS DOT PROJECT @ ROBERTS AND PETERBORO
MINUTES
July 24, 2008

Mayor Rouse opened the meeting at 7:00 p.m.

Mayor Rouse addressed those present and informed everyone of the issues that were addressed at the Village Board Meeting on July 7, 2008. The meeting was then turned over to Chris Mosher of DOT who reviewed the revised plans that the DOT developed as a result of the comments and concerns that were expressed by residents at the information meeting held by the DOT on June 11, 2008.

After reviewing the plans, Chris Mosher stated that since the plans as revised and presented tonight would be the plan that would be presented at the next meeting in August, he would suggest that the next meeting be canceled. Mayor Rouse asked that if any significant changes were made to the plans, that the meeting would still be held. Chris indicated that he would make us aware of any significant changes and would conduct another meeting.

Marie Sicilia thanked the DOT for taking their concerns into consideration and making revisions to the plan based on their concerns.

The Mayor asked the DOT to look at the intersection of Peterboro and Canal Streets for a possible left-turn signal for traffic going southbound on Peterboro turning left onto Canal Street. The DOT noted that this may require taking 2 parking spots on the west side of Peterboro Street in front of the Chinese restaurant.

Chris Mosher was asked about the time line for the project. Mr. Mosher estimated that the design approval should occur in the fall with a March 16, 2009 letting, which would get into an April to mid-May award which would give a contract start time of July or August to avoid backing up school traffic with construction in September.

Mayor Rouse asked if there were any other questions that anyone would like addressed with no response.
