

Canastota was awarded \$4.5 million to help complete transformative and/or catalytic projects in and near downtown. NY Forward funds are also used to provide robust capacity-building and technical assistance directly to communities throughout each phase of the program.

ABOUT NY FORWARD

This is the second year of New York State's NY Forward (NYF) program to invigorate and enliven downtowns in New York's smaller and rural communities. As a complement to the Downtown Revitalization Initiative (DRI), NY Forward focuses on creating healthy, vibrant, walkable downtowns that catalyze sustainable economic development and accrue numerous economic, social, and environmental benefits to the locality, the region, and the State as a whole.





Strong NYF Projects

- Clearly meet eligibility requirements
- Meet one or more NYF goals for downtown revitalization
- Have detailed project description* including
 - Site/floor plans
 - Artist view/rendering
 - o 3rd party cost estimates

^{*} Consultant team will assist sponsors after Open Call to develop/strengthen project details like budgets, cost estimates, renderings as needed



Strong NYF Project Slates

- Meet multiple NYF goals for downtown revitalization
- Mix of private and public projects
- Synergy between projects due to location (clustered together) and/or type (housing, retail, + recreation projects)



NYF Round 1 Example: Phoenix

11 projects (3 public) and \$4.5M NYF funding leveraging \$16,867,000 other funding for a total investment of \$21,367,000

- Mixed-use building façade enhancements and renovations (4)
- Create outdoor event space for successful distillery
- Renovate prominent building into restaurant + housing
- New primary care and daycare facilities
- Create canalside entertainment venue
- Expand marketing campaign
- Wastewater Treatment Plant expansion





- Interested project sponsors must submit a form to be considered by LPC and consultant team
 - Projects identified in village's application <u>still have to submit</u>
 to be considered
 - New projects encouraged!
- Consultant team will host in-person office hours to meet with interested sponsors and answer questions
- A webinar will also be held and recorded to go over the form

- Most sponsors will fill out detailed form projects greater than \$75,000
- These projects will be individually considered by LPC and consultant team
- Sponsors should provide as much information as possible.

- Project details may evolve during this period updated cost estimate or NYF request, etc.






